

TERMS AND CONDITIONS

1. These terms and conditions are our "**General Terms**" and they apply to every "**Competition**" that we, Ports of Jersey Runway Challenge 21, administer.

THE PROMOTER OF THE COMPETITION

ELIGIBILITY RULES FOR OUR COMPETITIONS
